AMS Onsite

AMS Onsite (Antimicrobial Stewardship Onsite) is a first-of-its-kind program designed exclusively for long term care (LTC). We designed this program 18 months ago in response to CMS' new regulations on Antimicrobial Stewardship (AMS) for long term care. CMS' new regulations were an effort to, 1) reduce over-prescribing of antibiotics in LTC (CMS suggests 60% of antibiotics in LTC are unnecessary) and 2) to help improve infection control processes and protocols. The program is offered at no charge to a LTC facility. The program details can be found on our website, but two exclusive components of our AMS program include an AMS Onsite Infectionist that regularly visits the LTC and manage the facility's AMS programs. We also provide quarterly testing of LTC residents for 36 respiratory pathogens, now also including COVID-19.
